

MINUTES of July 20, 2020 Regular Meeting Board of Public Works & Safety and Stormwater Board

Minutes of June 1, 2020 were presented.

Nichols/Landis moved to approve the minutes as presented. Passed 3-0

Mayor requested to add Item #15 (Rock Run Creek Improvements) and add Item #16 (Request for Sewer Relief for Spring Brook Association, 2321 College Avenue).

Nichols/Landis moved to approve the agenda as amended. Passed 3-0

Promotion of Zachary J. Bechtel from Probationary Patrol Officer to Patrol Officer

Chief of Police Jose' Miller presented the packet memo.

Nichols/Landis moved to approve the promotion of Zachary J. Bechtel from Probationary Patrol Officer to Patrol Officer effective July 22, 2020. Passed 3-0

Award of Surplus Property

Legal Contracts and Claims Manager Keitha Windsor presented the packet memo.

Nichols/Landis moved to award the sale of the surplus property listed to each of the individuals listed as the highest responsive bidders and give permission for the Mayor to sign the Bill of Sales. Passed 3-0

Request for Reduced Fee for City Trash Trailer

Mayor Stutsman presented the packet memo.

Nichols/Landis moved to approve a one-time reduction fee for city trash trailer fee to the West Goshen Neighborhood Association. Passed 3-0



Placement of Front-load Trash Container Request: 300 S. 21st St.

Martin Martinez Rojas presented his request to have a Front-load Trash Container at his property.

Stutsman/Nichols moved to table this request until the July 27, 2020 meeting. Passed 3-0

Sidewalk and Parking Space Closure, 113 West Washington Street Request

Karen Wellington presented her request to close the sidewalk and parking spaces in front of 113 West Washington Street from August 3 to August 5, 2020, weather permitting.

Nichols/Landis moved to approve the temporary closure of the sidewalk and parking spaces at 113 West Washington Street starting August 3, for three days, weather permitting. Passed 3-0

Closure of South 12th Street between College Avenue and Mervin Street

Water Department Superintendent Kent Holdren presented the packet memo.

Nichols/Landis moved to approve the Closure of South 12th Street between College Avenue and Mervin Street on Tuesday July 21, 2020 and reopen to traffic on Friday July 25, 2020. Passed 3-0

Request for Deaf Child Sign – 907 Zollinger Road. JN: Streets by Name - Zollinger

Director of Public Works Dustin Sailor presented the packet memo.

Nichols/Landis moved to approve the installation of the deaf child warning sign along Zollinger Road which is valid until the end of the calendar year. Passed 3-0

Request for Signs – 1112 Berkey Avenue JN: Streets by Name – Berkey

Sailor presented the packet memo.

Nichols/Landis moved to approve the installation of the deaf child warning signs along Berkey Avenue but deny the request for the "children at play" and the speed limit signs. Passed 3-0



Request for Stop Sign on Kay Parkway JN: Subdivisions - Clover Trails

Sailor presented the packet memo.

Nichols/Landis moved to approve the installation of a stop sign on Hay Parkway at the intersection with Park Meadows Drive. Passed 3-0

Bridge Inspections in 2020 and 2022 JN: 2020-0015

Sailor presented the packet memo.

Nichols/Landis moved to approve and award DLZ Indiana, LLC with the amount of \$20,970.00 for bridge inspections in 2020 and 2022 for the Engineering Department. Passed 3-0

Agreement with Baker Tilly for Utility Cost of Service Study, Rate Analysis, COVID-19 Impact

Windsor presented the packet memo.

Nichols/Landis moved to enter into an agreement with Baker Tilly to provide a Cost of Service Study and a COVID-19 Impact Analysis for the City's Water Utility at a cost not to exceed \$52,500.00 with the Cost of Service Study to be completed by February 1, 2021 and the COVID-19 Impact Analysis completed within six months from receipt of a notice to proceed. Passed 3-0

Agreement with OJS Building Services for Air Conditioner Replacement

Windsor presented the packet memo.

Nichols/Landis moved to enter into an agreement with OJS Building Services, Inc. to replace and relocate the three air conditioners at the Utilities Billing Office, 203 South 5th Street at a cost of \$26,510.00 with work to be completed within 10 business days from receipt of a notice to proceed. Passed 3-0

Access Agreement with NIPSCO for Sewer System Televising

Windsor presented the packet memo.

Landis asked if NIPSCO notifies the City when they are doing maintenance. Holdren responded that NIPSCO provides a quarterly maintenance schedule and will notify when maintenance will occur.



Nichols/Landis moved to approve the Mayor entering into an Access Agreement with NIPSCO to permit NIPSCO's access to televise the City's sanitary storm or combined sewer system for a period of 10 years. Passed 3-0

Acceptance of Easement from River Art, LLC

Legal Compliance Administrator Shannon Marks presented the packet memo.

Nichols/Landis moved to accept the easement from River Art, LLC and authorize the Mayor to execute the acceptance page. Passed 3-0

Resolution 2020-22: Local Roads and Bridges Matching Grant Agreement with InDOT for Reconstruction of 16th Street, Douglas Street and Reynolds Street

Marks presented the packet memo.

Nichols/Landis moved to authorize the Mayor to execute Resolution 2020-22; approve the terms and conditions of local roads and bridge matching grant agreement with InDOT for up to \$535,130.00 for the reconstruction of 16th Street, Douglas Street and Reynolds Street, east of Lincolnway East. Passed 3-0

Resolution 2020-23: Ratify Submission of City Claim in Bankruptcy Field by Purdue Pharma, L.P.

City Attorney Bodie Stegelmann presented the packet memo.

Nichols/Landis moved to ratify the submission of the bankruptcy claim on behalf of the City by City Attorney Bodie Stegelmann. Passed 3-0

Rock Run Creek Improvements

Sailor presented the request on behalf of Selge Construction for a road closure.

Request for Sewer Relief for Spring Brook Association, 2321 College Avenue

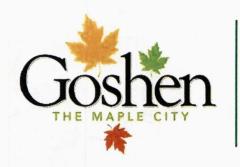
Holdren presented the request on behalf of the Spring Brook Association for sewer relief due to a leak.

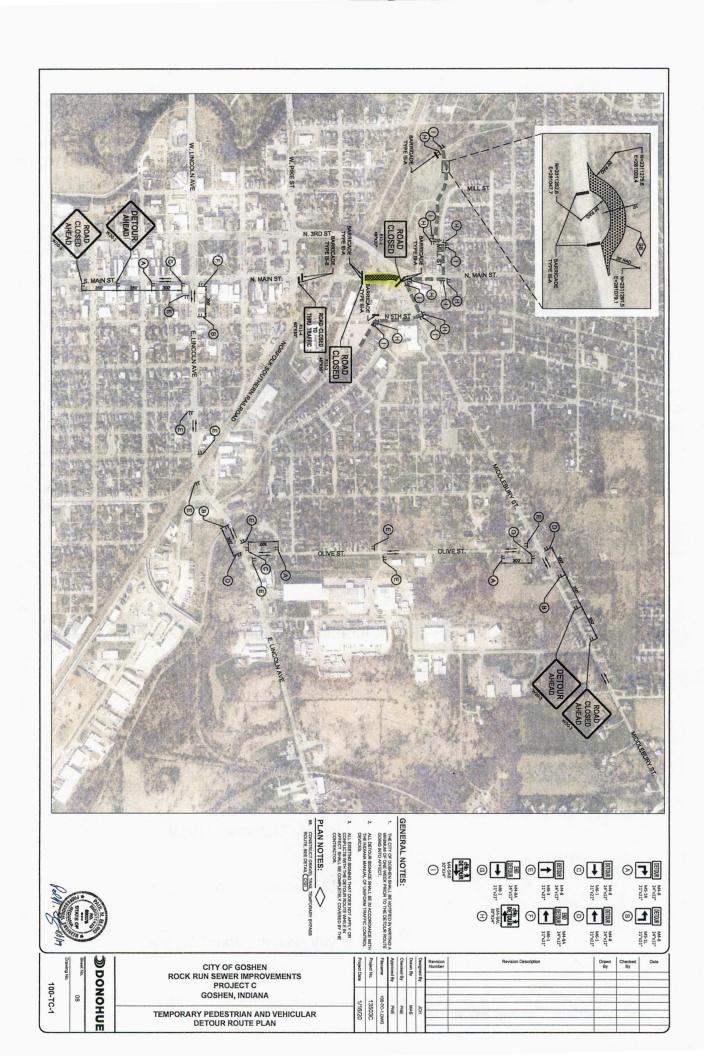

Re; Request for Sewer relief for Spring Brook Association, 2321 College Ave

On June 5th, 2020 The Goshen Water and Sewer Department was called to investigate a leak coming from the meter pit at Spring Brook. We were able to isolate the water leak and reroute it thru the fire protection meter. After pumping out the meter pit we were able to determine that the water did not enter the sewer. Therefore, the Sewer Department does recommend granting the request for credit.

If the Board of Works decides to grant relief for the sewer portion of Spring Brook Association's bill, the Utility Department has calculated the amount for relief as follows.

Customer Billed: \$25,048.26

Summer Sewer Break: \$6,696.43 Credit Should Be: \$ 18,351.83

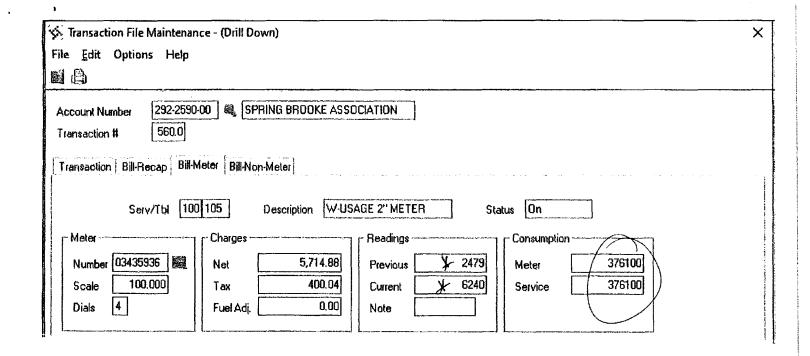
