REQUEST TO APPROVE PROMOTION - MEJIA

Police Chief Jose Miller requested Board approval to promote Gerardo G. Mejía from the position of Probationary Patrol Officer to the rank of Patrol Officer effective August 27, 2019.

As of August 27, 2019 Officer Gerardo Mejia will have completed his twelve (12) month probationary period. In addition, Officer Gerardo Mejia is attending the Tier I Basic Training Course at the Indiana Law Enforcement Academy and will be graduating in the next few weeks.

REQUEST TO APPROVE AGREEMENT-MASTER STEEL ROOFING

Legal Contracts and Claims Manager Keitha Windsor requested Board approval to award the Metal Roof Replacement at 320 Steury Avenue, Goshen (Q19-07-012) to Master Steel Roofing, Inc.

On August 19, 2019 the Board of Public Works and Safety opened quotes for Metal Roof Replacement at 320 Steury Avenue, Goshen. Only one quote was received.

It was recommended to the Board of Public Works and Safety to award the contract to Master Steel Roofing, Inc. as the lowest responsible and responsive quoter for a total contract price of \$96,807.60 along with permission to execute the contract.

Legal Contracts and Claims Manager Keitha Windsor approached the Board to give information on the Purchase of Road Salt for the 2019/2020 winter season.

In March, the Board of Public Works and Safety gave permission to enter the City's requirements onto the State's website for the purchase of road salt to be bid out by the State in a Quantity Purchase Agreement for the 2019/2020 winter season.

We have been informed that our contract for 1,000 tons of untreated road salt was awarded to Detroit Salt Company at \$86.45 per ton.

REQUEST TO APPROVE AGREEMENT—BILL'S HEATING

Legal Contracts and Claims Manager Keitha Windsor requested Board approval to enter into an agreement with Bill's Heating to provide and install the air conditioning unit and air handler Building Department and Building Inspector's Office at 204 East Jefferson Street.

The City wishes to contract with Bill's Heating, Inc. to provide and install the equipment.

REQUEST TO APPROVE AGREEMENT AMENDMENT—OJS BUILDING SERVICES

Legal Contracts and Claims Manager Keitha Windsor requested Board approval for an amendment to the agreement with OJS Building Services, Inc. to provide and install a new front end and controllers for the Building Management System in the Police and Court Building.

Work on the project was to be completed by August 31, 2019, however OJS has asked for an extension of one month.

Permission was requested to enter into this Agreement Amendment with OJS Building Services, Inc. to extend the term to September 30, 2019.

Board Member Day moved to approve the request. Second by Board Member Landis and motion passed unanimously.

REQUEST TO APPROVE AGREEMENT-SIGNTECH SIGN SERVICES

Legal Contracts and Claims Manager Keitha Windsor requested Board approval to enter into an agreement with Signtech Sign Services to replace seasonal lights and install the City's garlands and wreaths.

The City is replacing the City's seasonal lights with LED lighting and wishes to contract with Signteech Sign Services, Inc. to replace the lights and install the City's garlands and wreaths.

Work on the project shall be completed within 45 days from receipt of a notice to proceed and the total cost for the all work is \$28,122.50 (EID to pay \$20,000).

Board Member Day moved to approve the request. Second by Board Member Landis and motion passed unanimously.

<u>REQUEST TO APPROVE CONDITIONAL OFFER OF POLICE DEPARTMENT</u> <u>EMPLOYMENT WITH MICHAEL J. HECKATHORN</u>

Legal Compliance Administrator Shannon Marks requested Board approval to extend a conditional offer of employment to Michael J. Heckathorn and execute the Agreement which sets forth the prerequisites to begin employment as a patrol officer. Michael has previous training and experience as an Indiana law enforcement officer and is eligible to receive a hiring bonus of the \$8,000.00. Michael must first complete and pass the baseline statewide physical and mental examinations. The Board will be requested to confirm the offer of employment when a position opening becomes available in the Police Department.

Board Member Day moved to approve the request. Second by Board Member Landis and motion passed unanimously.

REQUEST TO APPROVE PROFESSIONAL SERVICES AGREEMENT—EARTH SOURCE, INC.

Administrative City Engineer Bryce Gast requested Board approval to enter into an agreement with Earth Source, Inc. to provide professional services for the Wetland Delineation for Rock Run Sewer Improvements (JN:2019-0025)

Goshen Engineering has solicited a professional services proposal from Earth Source, Inc. for wetland reconnaissance and delineation work to be performed in connection with the sanitary sewer construction through Allan J. Kauffman Park and across State Road 15, North Main Street and Rock Run Creek.

Based upon the City's request, Earth Source, Inc. offered a not to exceed service proposal fee of \$8,180.00 to complete a wetland reconnaissance, wetland delineation, report summarizing findings and onsite verification meeting with appropriate resource agencies.

Per the proposed agreement, the wetland delineation report will be submitted by September 13, 2019 and the onsite verification meeting will occur at a later date dependent on report findings and schedule availability.

Board Member Day moved to approve the request. Second by Board Member Landis and motion passed unanimously.

REQUEST TO APPROVE SIDEWALK & CURB 50/50 AGREEMENTS

Civil Traffic Engineer Leslie Bick requested Board approval for a Sidewalk & Curb 50/50 agreement with Allan Kauffman of 305 Gra-Roy Drive.

This Agreement was accepted after the others because Engineering was aware the homeowner was working on a deal with a tree company that damaged his sidewalk. The total cost is \$4,107.33. The resident has submitted their payments totaling \$2,053.67 and the City's portion will be \$2053.67.

Board Member Landis moved to approve the request. Second by Mayor Stutsman and motion passed unanimously.

REQUEST TO DISPOSE OF UNPAID FINALED UTILITY ACCOUNTS

Utilities Business Office Manager Kelly Saenz requested Board approval to move unpaid finaled accounts from active to collection, sewer liens, and write-offs. The original amount of unpaid final Water/Sewer accounts for the period was \$1,657.41. Collection letters were sent out and payments of \$538.91 have been collected. The uncollected amount equals \$1,118.50. These are accounts that were for the most part finaled through October 31, 2018.
